Cancellation by the participant

Certificate of participation

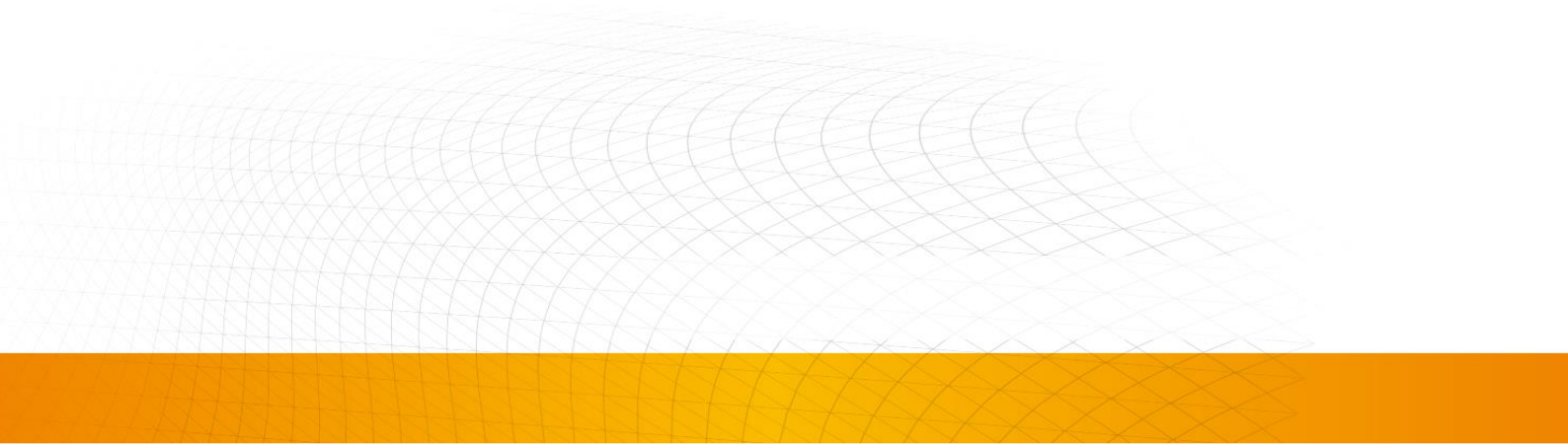
All participants receive a signed certificate upon completion of an Academy open seminar.
